



## **Bank with MeDirect & Win Terms and Conditions**

MeDirect Bank (Malta) plc, company registration number C34125, is licensed to undertake the business of banking in terms of the Banking Act (Cap. 371) and investment services under the Investment Services Act (Cap. 370). MeDirect Bank (Malta) plc is regulated by the Malta Financial Services Authority as a Credit Institution under the Banking Act 1994.

As a limited time offer, every new MeDirect Bank (Malta) plc. client (any person who does Participants agree to be bound by these Terms and Conditions and all other special conditions relating to the “Bank with MeDirect and Win” competition (“The Competition”).

1. The promoter is MeDirect Bank (Malta) plc (“The Promoter”), whose registered office is: The Centre, Tigne Point, Sliema, TPO 0001, Malta.
