

## Buy Model Portfolios Commission Free Terms and Conditions



Unless otherwise stated, all capitalised terms in these terms and conditions shall have the same meaning given to them in the 'General Terms and Conditions' or the 'Investment Services Terms and Conditions'.

As part of a limited-time promotion, no entry fees will be charged on model portfolio investments made via MeDirect Bank (Malta) plc (the "Bank") during the campaign period, which runs from 28 June to 30th September 2025 (inclusive of both dates)(the "Promotion").

- This Promotion applies exclusively to investments in model portfolios available through the Bank's platform during the campaign period.
